Applications to submit The Home Depot (HD) Foundation Community Impact Grant is scheduled to begin on February 1, 2017. Eligible VFW Posts may receive up to \$5,000 to fix up their buildings; however, of course, there is no guarantee of funding. Please note that the guide will not be emailed until HD Foundation Community Impact Grant application is reviewed first to ensure the how-to guide is up-to-date.

<u>The application must be filled out via the internet only</u> (**no** telephone calls, emails or written submissions to HD will be accepted **nor** will you be able to turn this application in at your local HD store).

If your Post receives funding, it will come in the form of HD gift cards that can be used to buy materials at your local HD store. You will need to recruit Post members or other community volunteers to do the work. The project must be completed within six months. You will also be required to fill out a final

project report. Failure to do so will negatively impact your Post's ability to receive any future funding from HD.

After submission of the application, you should receive a written email response from HD Foundation, usually within six weeks, letting you know if you received the grant.

Annual members will receive a *mailed renewal* notice 5 months, 3 months, and 1 month prior to their subscription end date. Annual members with a valid email address will also receive an *e-mailed renewal notice* 6 months, 4 months, and 2 months prior to their subscription end date.

Annual members will receive a *mailed lapsed notice* 1, 3, and 5 months following their subscription end date.

If you have not yet responded, you may receive a reminder letter in the mail. Your support is still urgently needed for the 2017 VFW NVS Annual Campaign. Your donation right now ensures the VFW's national force of highly trained service officers is at the ready to help America's veterans navigate the complicated VA system.

Along with the reminder letter, you will find a Special Veterans' Petition addressed to the President, the Senate Majority Leader and the Speaker of the House. #### NATIONAL VETERANS SERVICE:

#### VFW Accredited Service Representative of the Year Award

National Veterans Service (NVS) is now accepting nominations for the VFW Accredited Service Representative of the Year Award. This award is designed to provide annual recognition to an

individual accredited by VA to represent claimants on behalf of the VFW before the Department of Veterans Affairs, to include employees of state veterans agencies, who meets the below criteria.

#### **ELIGIBILITY:**

Eligible nominees include:

- Department Service Officers
- Assistant Department Service Officers
- Claims Consultants/Representative/Analysts/Reviewer
- Veterans Service Officers/Representatives

Individuals **NOT** eligible for this award are:

- VFW National Staff
- VFW Contractors
- VFW accredited representatives whose primary employer is other than the VFW or a state veterans agency

#### **SELECTION CRITERIA:**

- 1. Nominees for the annual award must have demonstrated exceptional efforts in assisting veterans and their families during the 12 months preceding the **April 30** deadline.
- 2. A brief summary (no more than 2 pages) is to be submitted which explains the **who, what, when, where**, and **how** the nominee's efforts are considered exemplary. Suggested items for consideration (but not limited to):
  - # of individuals with VFW POAs assisted
  - Community outreach conducted
  - Excellent customer service provided (examples required)
  - Use of VetraSpec or another electronic claims processing system (specify system)
  - Submission of <u>TIMELY</u> monthly reports (if located in a VA regional office)
  - # of VFW members recruited

#### **AWARDS:**

Each Department commander may nominate <u>one</u> eligible individual for this award. The individual who is ultimately chosen as the recipient of the award will be furnished round-trip travel (for the winner and one guest) and two night's hotel accommodations to attend the VFW National Convention where the award will be presented. A stipend in the amount of \$599.00 will also be given to the recipient to cover out-of-pocket expenses incurred in connection with the trip.

The selection committee will review NVS's Team Support database to view the number of incidents (both positive and negative, if any) reported to NVS. Additionally, the results of test scores at VFW NVS training, results of any site visits, and other criteria MAY be used in making the final decision.

Nominations may be sent to the **Director, VFW National Veterans Service**, either by mail (200 Maryland Ave., NE, Washington, DC 20002, ATTN: Service Officer Award), faxed to 202-547-3196 (ATTN: Service Officer Award), or scanned and emailed to taldana@vfw.org.

Nominations must be received not later than April 30.

#### "BUDDY"® POPPY:

Although we emphasize "Buddy" Poppies on Veterans Day and Memorial Day, it is important to realize that the distribution of "Buddy" Poppies should be a year-round exercise. Each time a Post participates in an activity where the public will be present, "Buddy" Poppies should be present as a fundraising tool and simply to recognize our fallen comrades. Where the VFW appears, "Buddy" Poppies should be a reminder that we will never forget those who have perished in the name of liberty.

Just as "They Gave, Will You?" is a year-round thing, so should the distribution of VFW "Buddy" Poppies.

Remember that your poppies should be ordered a minimum of 8 weeks in advance of your distribution date. Be sure to specify a date by which the poppies are required, do not use "ASAP." Miscellaneous items (coin cans, buttons, posters, etc.) should be ordered directly from the VFW Store at <a href="http://www.vfwstore.org/category/programs/buddypoppy">http://www.vfwstore.org/category/programs/buddypoppy</a> or the VFW Store/Emblem and Supply Catalog.

VFW SILVER, GOLD AND DIAMOND ANNIVERSARY POPPIES. The silver, gold and diamond anniversary "Buddy" Poppies are only for Posts that are currently in their 25th, 50th, 75th or 100th anniversary years. The anniversary poppies are approximately three times as expensive for us to produce, but because of the small quantities we deal in, we don't pass those costs on to the Posts. The bigger issue is that we simply don't have the inventory on hand to fulfill the potential orders that could come in if we open these items up to be ordered by anyone at any time.

The Manual of Procedure provides that Post relief funds may be used for programs such as Voice of Democracy, Patriot's Pen, Citizenship Education, and Community Service as long as suggestions in the chairmen guidebooks are used as an example of promoting these programs.

Posts are further reminded that Section 711 of the Manual of Procedure provides that not-for-profit organizations, exempt from taxes under Section 501(a) of the Internal Revenue Code, may assist with the distribution of "Buddy" Poppies, provided there shall be no division of proceeds. A donation to these groups may be made from the Post general fund.

#### **PROGRAMS:**

VFW Posts and Auxiliaries reported donating almost 3.2 million volunteer hours and over \$17 million toward community service work from May 1 to October 31, 2016. The total value of our volunteers' efforts is valued at over \$93 million.

**DISPLAYING MILITARY SERVICE SYMBOLS.** Military service flags, insignias, etc., should be displayed in the following order (left to right as you face the flags): Army, Marine Corps, Navy, Air Force and then Coast Guard. #### SMART/MAHER VFW NATIONAL CITIZENSHIP EDUCATION TEACHER OF THE YEAR.

The VFW wants to recognize the nation's top elementary, junior high and high school teachers (teaching at least half of the school day in a classroom environment) who teach citizenship education topics regularly and promote America's history, traditions and institutions effectively through the Smart/Maher VFW National Citizenship Education Teacher Award program. Nominations can be submitted by fellow teachers, VFW Posts, supervisors or other interested individuals (not relatives). Self-nominees are not eligible.

**Important Deadlines:** Here are the deadline dates for the program:

February 15, 2017 – Teacher Nominations to the Post

February 28, 2017 – Completion of Post Judging

March 15, 2017 – Completion of District Judging

March 30, 2017 - Completion of Department Judging

April 1, 2017 - District Participation Reports due to Department Chairmen

April 5, 2017 – Department Winners to National

April 15, 2017 - Department Reports to National

Now is the time to begin locating exceptional teachers for your Post to nominate for next year's competition. Based on the nominees submitted by the February 15 deadline, local VFW Posts will recognize one outstanding teacher in grades K-5, 6-8 and 9-12. Posts then submit the winners' names to their District level judging who will forward their winners to the Department (or state level) by March 15. After judging, each Department forwards the names of its winners to VFW National Headquarters for consideration in the national awards contest.

VFW's National Citizenship Education Teacher awards include: three national \$1,000 awards for the top K-5, 6-8 and 9-12 teachers for professional development expenses; \$1,000 award to each winning teacher's school; plaques for both the winning teacher and school; and an all-expenses-paid trip to attend a VFW and Auxiliary national event.

SCOUT OF THE YEAR PROGRAM. Annually, the VFW awards three individuals who are: Eagle Scouts, Girl Scout Gold Award recipients, Venture Summit Award recipients and/or Sea Scout Quartermasters who have risen above their peers in exemplifying the qualities of that rank. An applicant has to have reached his or her 15th birthday and be enrolled in high school at the time of selection. Awards are as follows: \$5,000 – 1st place scholarship, \$3,000 – 2nd place scholarship and \$1,000 – 3rd place scholarship. The deadline for entry to a VFW Post is March 1. **50TH ANNIVERSARY VIETNAM WAR COMMEMORATION PROGRAM.** The Commemorative Partner Program is designed for federal, state and local communities, veterans' organizations and other non-governmental organizations to assist a grateful nation in thanking and honoring our Vietnam Veterans and their families. As a Commemorative Partner, VFW Posts are encouraged to participate in the Commemoration of the Vietnam War by planning and conducting events and activities that will recognize the Vietnam Veterans and their families' service, valor, and sacrifice.

Events and activities should be dignified, memorable occasions that show a sensitivity and appreciation for the solemnity of war and the losses suffered by many. Commemorative Partners should communicate how their events will achieve the Congressionally-mandated objectives of the program. Events or activities should meet one or more of the following objectives.

- 1. To thank and honor veterans of the Vietnam War, including personnel who were held as prisoners of war or listed as missing in action, for their service and sacrifice on behalf of the United States and to thank and honor the families of these veterans.
- 2. To highlight the service of the Armed Forces during the Vietnam War and the contributions of Federal agencies and governmental and non-governmental organizations that served with, or in support of, the Armed Forces.
- 3. To pay tribute to the contributions made on the home front by the people of the United States during the Vietnam War.
- 4. To highlight the advances in technology, science, and medicine related to military research conducted during the Vietnam War.

5. To recognize the contributions and sacrifices made by the allies of the United States during the Vietnam War.

For VFW Posts interested in becoming an official Commemorative Partner, they must submit an application and a signed Statement of Understanding.

Applications are available at www.VietnamWar50th.com on the Commemorative Partner Program. The approval process is usually less than 30 days. Partners will be kept informed through electronic notifications. Once approved as a Partner, the Commemoration will provide organizations with a starter kit of materials for developing and implementing their programs. **VFW SPECIAL PROJECT PROGRAM UPDATES.** This program was put in place to recognize VFW units for creating and completing unique and extraordinary community service projects.

Record book entry nominations that are found to be complete and well-substantiated should be endorsed by the Department adjutant or VFW Department community activities chairman and forwarded to the National Programs Department. Deadline for entries is April 30 of each year. All entries receive a Community Service Citation. Noteworthy entries receive a Merit Award Plaque. Exceptional entries receive an *Award of Excellence*.

**NEW** - \*A maximum of eight (8) Posts per conference who receive the *Award of Excellence* in the May Special Project judging will receive a \$5,000 Community Service Grant. \*A maximum of \$40,000 per conference will be awarded. This may be less if fewer than eight (8) Posts receive the *Award of Excellence*. \*Those qualified Posts that have earned the *Award of Excellence* will then compete for the Fred C. Hall Award and could earn an additional \$5,000 and attendance at National Convention.

**NEW VOICE OF DEMOCRACY AND PATRIOT'S PEN THEMES.** The 2017–2018 themes have been chosen by Senior Vice Commander-in-Chief Keith E. Harman. The Voice of Democracy theme will be "American History: Our Hope for the Future" and the Patriot's Pen theme will be "America's Gift to My Generation."

NEW VOICE OF DEMOCRACY AND PATRIOT'S PEN DEADLINE DATE. Please update all websites, publications, announcements, etc. with the new student entry deadline for the 2017-2018 program year. It will now be October 31, 2017 (instead of November 1, 2017) for both the Voice of Democracy and Patriot's Pen contests. The updated entry form will be up on the VFW website no later than April 1 and will be available from the VFW Store soon after that.

WORLD WAR I COMMISSION PARTNERSHIP. In observance of the upcoming centennial of World War I, 100 matching grants of up to \$2,000 apiece will be awarded for the restoration of 100 World War I Memorials across the United States. Any municipal government, individual, or organization may apply. The purpose of the program is to get local communities involved in recognizing and commemorating the WWI centennial and assisting them in restoring their local memorials. Pritzker and WWICC have jointly allocated \$200,000 for matching grants. Very little has been

dispersed so far, as they expect most applications to come in closer to the deadline which is June 15, 2017. Applicants have until November 11, 2018, to complete their projects.

More than 100 projects will be supported. The top 100 will be highlighted in a coffee table book. All projects will be listed on their website.

The VFW's role is to help publicize the program and get local Posts (and Auxiliaries) involved.

POW/MIA FLAG -- OFFICIAL DISPLAY DAYS. Public Law 105-85 (November 16, 1997) indicates the days that federal agencies, military installations and U.S. post offices are required to display the POW/MIA flag. The days are: Armed Forces Day, May 20, 2017 (third Saturday in May); Memorial Day, May 29, 2017 (last Monday in May); Flag Day, June 14; National POW/MIA Day, September 15, 2017 (third Friday in September); Independence Day, July 4; and Veterans Day, November 11. ## NATIONAL HEADQUARTERS VETERANS OF FOREIGN WARS OF THE UNITED STATES

General Orders No. 7 2016-17 Series

- 1. Attention of Post Commanders is directed to Section 222 of the National By-Laws and the Manual of Procedure, which provides that each Post will pay, in advance, a National Convention registration fee of twenty-five dollars (\$25) which shall entitle the Post to a packet of convention information and materials and one identified registered delegate for the National Convention. Each additional delegate attending the National Convention will pay a ten dollar (\$10) delegate fee. Posts are encouraged to register their Post delegate(s) online through the Online Membership System (OMS) or by submitting their National Convention Post and Delegate Registration form that will be mailed to all Posts as part of the Election Report/Convention Registration mailing going out this month. Registration forms for the 118th National Convention should be mailed to: Convention Registration, 406 West 34th Street, Kansas City, MO 64111.
- 2. Attention is directed to Section 217 of the National By-Laws and the Manual of Procedure covering the nomination, election and installation of Post Officers. Post Election Report forms are being mailed to Post Quartermasters with instructions that they complete the form online through the Online Membership System (OMS) or they can complete the form and return directly to National Headquarters <u>immediately following</u> the election of Post Officers, by not later than June 1.
- 3. Section 222 of the National By-Laws and the Manual of Procedure provides that Posts shall elect delegates and alternates to District conventions at a regular meeting of the Post held not less than thirty (30) days prior to the District convention at which District officers are to be elected: one (1) delegate and one (1) alternate for each thirty (30) members or fraction thereof in good standing in the Post at the time of the election.

Delegates and alternates to the Department conventions shall be elected at a regular meeting of the Post held not less than thirty (30) days prior to the Department convention. Posts are entitled to one (1) delegate and one (1) alternate for each thirty (30) members or fraction thereof in good standing in the Post at the time of the election.

4. Pursuant to Section 403 of the National By-Laws and the Manual of Procedure, each District shall hold an annual District convention for the purpose of electing District officers, such convention to be held not less than ten (10) days nor more than seventy-five (75) days prior to the convening of the Department convention.

Pursuant to Section 403 of the National By-Laws – Regular Meeting, Districts shall hold at least two (2) regular meetings each year for purposes of transacting business and conducting schools of instruction.

Pursuant to Section 417 of the National Manual of Procedure, District officers shall not assume the duties of their office until the Department Commander is installed.

District officers shall not be installed or assume the duties of their office until proof of eligibility has been submitted and properly reviewed in accordance with Section 416 of the Manual of Procedure.

5. Attention of Post Commanders is directed to Section 218 (a)(11) of the National Manual of Procedure, Officers: Duties and Obligations. Trustees Report of Audit must be prepared in detail within thirty (30) days from the end of each quarter, one of which ends March 31.

6. Certificates of charter evidencing consolidation have been issued to the following Posts:

Post Nos. 4737 and 4741 are consolidated as Post No. 4737, Highland Park, Illinois
