- 1) MUST BE 18 OR OLDER TO PARTICIPATE
- 2) THIS IS A RAIN OR SHINE EVENT
- 3) Each team must have a current Class B fire extinguisher
- 4) RV's and Campers are welcome; they must fit in the space reserved. Each team must be self-contained; there will not be any space between your space and the space next to you
- 5) Electrical hookups (sign-up required) and water available; generators are allowed

  a. Electric Service is 1-20amp Standard Plug
- 6) Entry includes parking of only one vehicle in your team space; it cannot be moved until the event is over. Due to safety concerns, there is absolutely **no vehicle movement** allowed during the event, beginning 5pm Friday, April 20, 2018
- 7) Teams shall keep their spaces clean of litter and trash throughout the event, including the disposal of cigarettes
- 8) All trash must be properly bagged and placed at the front of your space for pick-up; if not placed at front of space, team is responsible for placing in the dumpsters
- 9) There is a \$35 NSF fee for all returned checks. This fee plus the entry fee must be paid in full with cash or cashier's check prior to the event
- 10) Cancellation policy: 100% prior to 4 weeks, 50% 4 2 weeks prior, no refund within 2 weeks of the event. Extenuating circumstances will be evaluated on a case by case basis.

Waiver of Liability: In consideration of your accepting this entry, I, the undersigned, intending to be legally bound, hereby for myself, my heirs, executors and administrators, waive and release any and all rights and claims for damages I may have again the Veterans of Foreign War Post 846, its officers, representatives, successors, and assigns for any and all injuries suffered by me in this event.
