POW/MIA REPORT... RAY CALORE, Chairman



What can you do to help? Here is one idea that is very simple: There is a bill in the U.S. Senate, S.120, that will make it easier to keep track of US military personnel in the instance of their being missing in action or POW. In short, S.120 will "...provide for the creation of the Miss-

ing Armed Forces Personnel Records Collection at the National Archives, to require the expeditious public transmission to the Archivist and public disclosure of Missing Armed Forces Personnel records, and for other purposes."

Now here's what you can do: Call (202) 220-3121 and ask for one of YOUR Senator's office. When you get there ask to speak to who ever handles Veteran and POW/MIA issues. Leave the message on their voice mail that you want your senator to co-sponsor and support S.120. Call the number (202) 224-3121 again and ask for your other senator and repeat what you did with your first senator.

Now you can say you did something important for our Veterans and POW.MIAs. **Thank You.**


