Meeting night, 2nd Thursday of the month, open from 4pm.








# DESERT THUNDER

The Desert Thunder Riders Group will be doing a memorial ride from San Antonio TX to Washington DC to raise money for the Desert Storm Memorial. This is their inaugural event and they have chosen **VFW Post 846** as their stop through KC. Join us for a night of great food, entertainment and camaraderie to honor Operation Desert Storm Veterans.



**2018 is the 30th YEAR** for the Run For The Wall. This 10-day ride begins in California and ends at the Vietnam Veterans Memorial in Washington, D.C. The finale is the **Rolling Thunder Parade** on the Sunday night before Memorial Day, where bikers ride from the Pentagon to the Wall.

Over 300,000 bikers will participate! Going across Kansas, the riders will stop overnight on <u>May 20th in Junction City</u>, at the Heritage Park Veterans Memorial, 6th & Washington, at 5pm. They will be welcomed by featured speaker RAY CALORE, past VFW state commander of Kansas.


