# Resolving "Last Known Alive" Cases

- Of the original 196 individuals "Last Known Alive" in Vietnam (those who survived or may have survived their loss incident and were either alive on the ground, in captivity, or in immediate proximity to capture, but did not return), DOD has confirmed the death of 177, with 19 still unresolved.
- Of the 177 whose deaths have been confirmed, the remains of 51 have been located and identified; efforts continue to recover the remaining 126.
- U.S. and Vietnamese specialists met in Hanoi last year to discuss Last Known Alive cases in Vietnam, as well as in Cambodia and Laos.

**NOTE:** Due to recent current events, The *National Alliance of Families* is focusing on "The Last Known Alive" Initiative. The Initiative is to provide America information on just that, "The Last Known Alive" — Service members of America's finest knowingly left behind... alive.
